#### Paid Prenatal Leave Law going into effect January 1, 2025

Governor Hochul is committed to making sure all pregnant New Yorkers can get the care they need. Beginning January 1, 2025, New York will become the first state in the nation to offer paid time off for prenatal care or any medical care related to pregnancy.

Under this new policy, any privately-employed pregnant New Yorker will be able to receive an additional 20 hours of paid sick leave for prenatal care in addition to their existing sick leave, ensuring they can receive the care they need without putting their employment at risk.

### NYSFDA State Report Peter D'Arienzo - Region 9 Representative

Greetings,

As we closeout this year here a few items and trends that I can update our membership on both the national and New York State levels.

The 2024 NFDA consumer survey has been released and the items that caught my eye were:

an increase in online shopping via posted price information on funeral home websites

(where allowed or mandated) and the use of google or yelp reviews where the family eithers confirms an appointment or chooses not to visit a particular location based on what information and pictures are posted online.

- stronger reliance on funeral home websites and social media platforms to obtain the obituary and the funeral service information.
- · a decrease in the utilization of traditional clergy and a corresponding uptick in the use of funeral celebrants.
- more families are requesting to incorporate the livestreaming of either the visitation, funeral ceremony or the committal service.

Here in New York State we continue to look at two key issues regarding the workforce issues:

- the transporter issue went to the advisory committee and we are now awaiting feedback from the Department of Health on its status.
- NYSFDA President Scott Hendrix formulated an Ad-Hoc committee to investigate the split licensure option which has become more popular on a national level. New York remains one of only eight states without this option and two of those eight states are in the process of changing their laws to introduce it which lowers the number of states without it across the country to just six. I have been appointed to be a member of this committee. A survey was sent out to all members of NYSFDA in November and those results are being tabulated and the information and responses that were received will allow us to present potential licensing options in the future that work for all parties involved.

By the time this is published I will have traveled to Albany for three days of meetings in December and will report back to our board on any updates that I receive. That is all I have for now.

The holiday season is one of my favorite days of the year and I sincerely hope that you can spend some quality time with family and friends and share some delicious food together and take a moment to be grateful as we all have something to be thankful for! Wishing everyone a wonderful holiday and happy new year!




